Biographical notes: Robert L. Levenson, May 20, 1915-May 31, 1990 (according to Social Security Death Index. Obituary gave his age as 74) Levenson was the president of Reichart Furniture Co., co-founder of Wheeling Antenna Co., and one of the original investors in the Wheeling Ironmen Football team. He was founder and first president of Downtown Wheeling Associates and member of Wheeling-Ohio County Planning Commission, Wheeling Parking Authority, Wheeling Area Conference, the Urban Renewal Authority and many other bodies.
